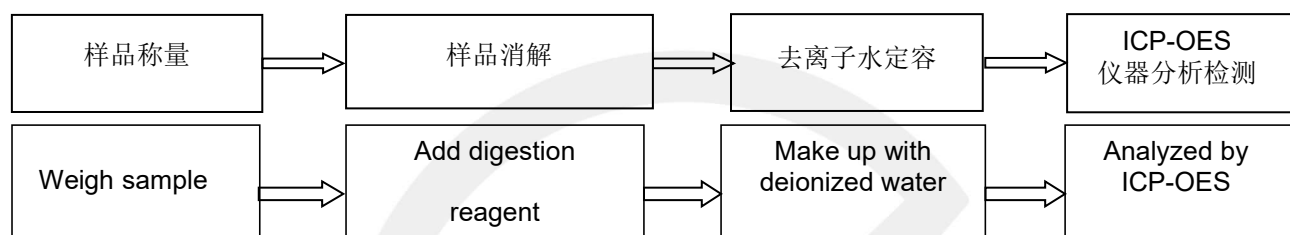

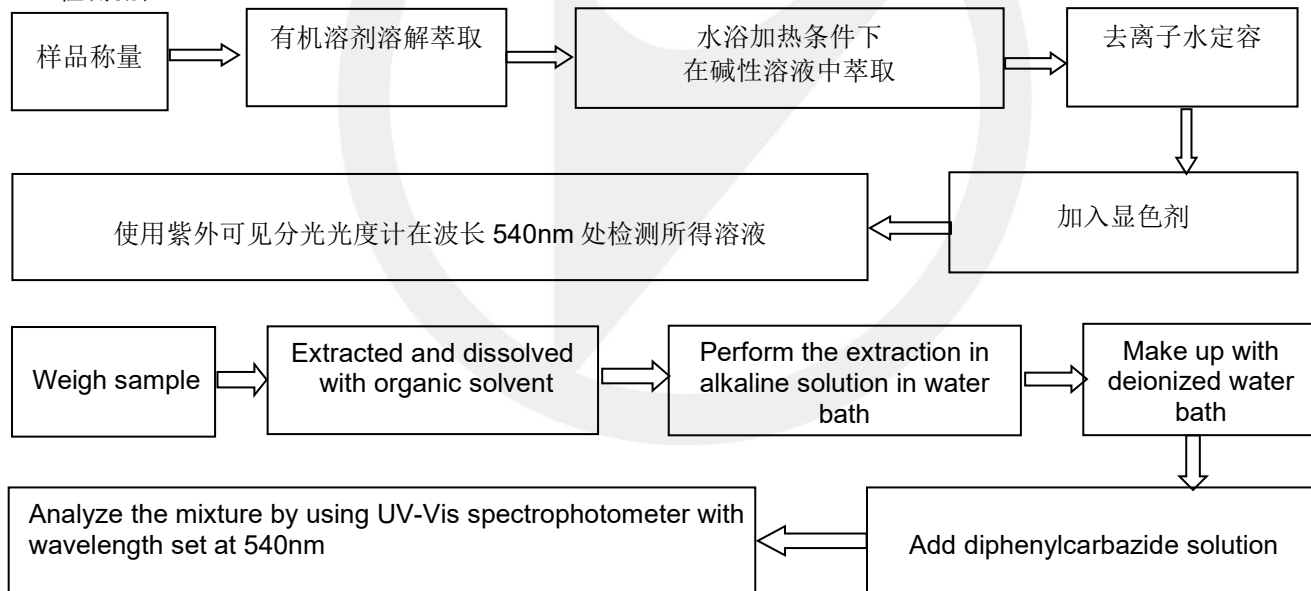

## 1.4 检测流程图 Test Flowchart

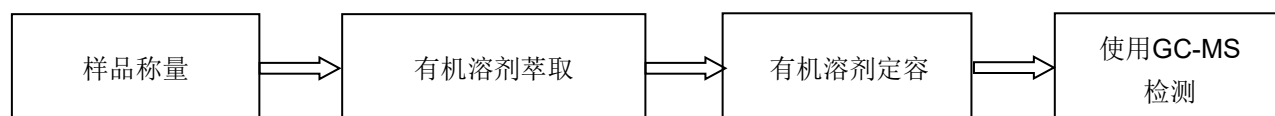
Pb, Cd, Hg 检测流程/Pb, Cd, Hg Test Process :

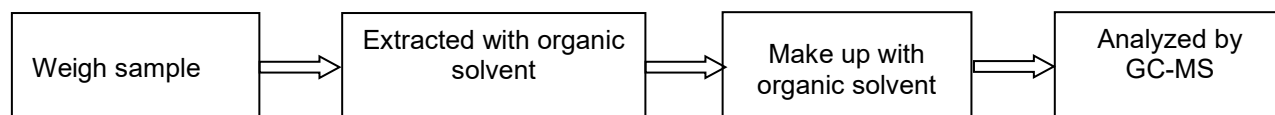
